RESUME OF THE 80TH NATIONAL CONVENTION OMAHA, NEBRASKA MAY 17-18, 2024

- The formal opening was on Friday, May 17, 2024, at the Embassy Suites by Hilton Omaha Downtown Old Market. The Omaha Chapter President Anne Menichetti welcomed members to the convention. Past National President Pat Cohen gave the response. President Ida Carmouche introduced the national board members and welcomed the Emeritus Council members present. Chapter Women of the Year were introduced by Sylvia Long, National 1st Vice President. Seven of the eight nominated women were present.
- The Presidents Brunch was hosted by 2nd Vice President Yolanda Barbosa. The invocation was given by Melanie McKim, Central Florida Chapter. Presidents and chapter representatives read their activities for the past year. Emeritus Council members were introduced. Scholarship Chair Peggy Simon Cuellar reported on Scholarship Fund Donations. The Welfare Chair Rhonda Gomez reported on chapter donations and thanked the ten chapters who submitted their volunteer hours, monetary donations, and their 2023-2024 Good Samaritan reports. Sylvia Long National 1st Vice President announced the 2024 Women of the Year, Theresa Harper, past national president, Houston Chapter.
- On Friday, The Business Meeting opened with Credentials Chair, Rae Huebner, Philadelphia Chapter, announcing the voting strength of 46 members, establishing a quorum. President Carmouche gave a State of NARBW address. As President Carmouche's second year as president, she is happy to report we have preserved our 13 chapters and 4 Members at Large. First time convention attendees were introduced. National Treasurer, Jasmine Manley presented the Treasurer's reports which were discussed and approved as amended. Sandy Hall, Nominating Chair presented the slate of officers for election; there were no nominations from the floor. - The second day of business meetings began with a voting strength of 46 members. National President, Ida Carmouche asked Past National President Sandy Hall to move for a voice election of the unopposed, nominated officers. Sandy then performed the installation ceremony for the new officers: Rhonda Gomez is the incoming national president, Dana Robles is the incoming national 1st Vice President, and Julie Nelson is the incoming National Treasurer.
- National President Ida Carmouche invited Jay Nelson, Omaha Chapter, to present jewelry she has received from Jane Sebeczak Clapper's daughter to auction with the proceeds going towards the National Scholarship Fund.
- The Membership Luncheon was hosted by 3rd Vice President, Trischelle Baysden. The invocation was given by Jasmine Manley, Chicago Chapter. Trischelle Baysden welcomed everyone and introduced the six members attending their first convention.

PRESENTING THE 2024 NATIONAL WOMAN OF THE YEAR THERESA HARPER - HOUSTON CHAPTER

The National Association of Railway Business Women (NARBW) is proud to announce that Theresa Harper has been selected as the 2024 Woman of the Year. According to Theresa, "Volunteers do not necessarily have the time; they have the heart," and she has certainly embodied this sentiment through her service to NARBW. Theresa joined NARBW's Houston Chapter in 1980, and has held over a dozen leadership positions at the chapter, district, and national levels, including chapter president, district director and national president.

She is currently an active member of the Emeritus Council and is the Houston Chapter's treasurer. Theresa provides leadership to our members and graciously shares her experience and vast knowledge of NARBW history.



Since joining NARBW, Theresa has always been very active. She has hosted chapter meetings, supported fundraisers and has attended "40" national conventions. Over the years, Theresa represented NARBW on the Federal Railroad Administration's Railway Safety Advisory Committee and also participated in Houston's National Transportation Week. She is also heavily involved in NARBW's charitable activities including breast cancer and Alzheimer research initiatives and has supported the Houston Chapter's efforts to collect items for military care packages, volunteered at the Houston Foodbank, and supported Wreaths Across America and the Veteran's Card Project. She is a supporter of her chapter fundraising activities by participating in raffles for designated causes and working at the Houston Astros baseball games. Operation Lifesaver presentations and activities are also important to Theresa, as she has investigated and been on the scene of several grade crossing accidents.

Growing up in a railroad family, Theresa understood the significance of railroads in our nation's commerce. Her railroad career began as a clerk at the Houston Belt & Terminal Railway Company (HB&T), and she steadily advanced in the industry. She later was promoted to transportation supervisor and city railroad coordinator. At the closing of HB&T, she transferred to the Union Pacific Railroad as the city railroad coordinator, then became manager of public projects. In 2001, Theresa accepted the position of director of operations with the Texas City Terminal Railway Company/Port of Texas City; and was later promoted to vice president/deputy director. Theresa retired in 2017 after an impressive 42-year career.


In addition to NARBW, Theresa has served as a board member and vice president in her homeowner's association and recently revised the neighborhood Architectural Control Guidelines. Theresa coordinated the National Night Out in October each year for her homeowner's association. She has also maintained her Texas Real Estate Salesman License since 1996 and is current with her continued education hours.

Central Florida Chapter - Gail Hendrix



Gail is a charter member of Chapter 83 Central Florida, chartered in July 2015. She was the chapter's first welfare chair. Gail also stepped into the position of chapter secretary after the first secretary stepped down for health reasons. She was elected president in 2021-2022 and 2022-2023. During this time, she continued to hold the welfare chair position, and mid-term she also served as secretary. She is currently secretary and Welfare Chair.

Gail has been instrumental in establishing benevolent relationships with the United Methodist Children's Home, the Sanford Outreach Mission, the Neighborhood Center, and the Pace Center. With her guidance, the chapter donated toys at Christmas to both the Children's home and Outreach Mission, and personalized items for the girls at Pace. With the Outreach Mission, she organized and collected Mother's Day bags for ladies in the shelter and organized backpack

collections for needy students. Gail has volunteered at the Heart & Home Thrift Store which benefits The United Methodist Children's Home. She has set up annual food drives for The Sanford Outreach Mission and The Neighborhood Center. Her donation helped buy additional food. She set up a community volunteer day at a local no kill animal shelter and she cleaned cat houses. Through her, the chapter sponsored several charity walks. Gail has worked on her church's kitchen committee and taught Sunday School.

Gail is an Army veteran and enjoys talking about her service time to young chapter members. She began her railroad career as a Ticket/Baggage Agent in Pittsburg (she worked in PA for 32 years). In Sanford, she worked as an Auto Train Rep; the Training Resource Employee (helping train new hires as Ticket/Baggage Agents); and with Operation Redblock. She received the Bronze, Silver, and Gold Stars for Customer Service Excellence; the Amtrak President's Service and Safety Award for Sustained Excellence; and the Above and Beyond Award from The Auto Train Sanford Station as "Caregiver." In 2016, she retired from Amtrak after 37 years of service. After retirement, she worked for Home Instead Senior Care. Gail is a Caregiver in every sense of the word.

Chicago Chapter - Ruby Brownlee



Ruby has been a dedicated member for nearly seven years. Although she never worked for a railroad or railroad affiliate, she has an unwavering commitment to NARBW. She was introduced to NARBW through her daughter Jasmine Manley. Since joining the Chicago Chapter in July 2017, Ruby has consistently attended chapter meetings and always volunteers for NARBW activities and projects. She served as Welfare Chair for two years. She was an integral part of the Chicago Chapter's 2022 Convention Planning Committee. She has attended every Convention since joining, has been a Delegate for several years, and has served as both a Timekeeper and a Page. She has also worked at the chapter's Marketplace table, helping to raise funds for the chapter.

In the community, Ruby has packaged meals at Feed My Starving Children and the Greater Chicago Food Depository; volunteered at the Knight Ministries assembling wound care and hygiene kits for those in need; supported the chapter's *Chicago Books to Women in Prison* drive;

and the Winter Wear Drive for School Kids. She participated in breast cancer walk-a-thons and helped prepare meals for families at the Ronald McDonald House and La Casa Norte (which serves the homeless). Ruby has participate in chapter fundraisers (Super Bowl Squares, Bingo, Bakers Square pies, and raffles). She has worked the chapter's membership table at Metra Family Day Picnic and the chapter's virtual membership drives. At church, Ruby served on the Nurses Board, was appointed to the Mothers Board, and she volunteers with the monthly *Feed the Hungry* program.

Ruby works as an Administrative Assistant for the Human Resources Development Institute, Inc. (HRDI), a community behavioral health center supporting underserved communities. It provides prevention, intervention, and treatment services to address various mental health, substance use, and health concerns. During the COVID 19 pandemic, Ruby was recognized for being an essential worker. Prior to HRDI, Ruby worked in the banking industry for over 30 years.

Jacksonville Chapter - Lori Ledoux



As Sunshine Chair for the Jacksonville Chapter, Lori sends greetings and well wishes to the chapter members. She participates in Board and chapter meetings and supports the chapter's social and volunteer activities. She has planned multiple events and hosted events in her home. Lori assisted the Ways and Means Chair with fundraising activities and co-chairs with the Convention Marketplace. She was a member of the 2021 National Convention team, assisted with updating the Convention Handbook, and provided support to the 2023 Convention Chair for the San Diego Convention. She has been a delegate at multiple Conventions.

In the community, Lori became a volunteer at Pace Center for Girls shortly after joining NARBW. She works on Ms. Mary's Boutique, Family night, and prom shopping events as well as graduation

events. Lori is a key member of the Pace Annual Silent Auction team and the Annual Fundraising Luncheon team. In 2023, she helped design the in-school boutique at the Pace Center. She supports local charities such as 3 Grains of Rice and Habitat for Humanity. She has put up siding, done landscaping, and painted homes. She participated in an early education program by reading to underserved preschoolers. Lori volunteers by decorating at the Bailey Hospice in St. Augustine at Christmas and Easter egg stuffing for the Malivai Washington Youth Foundation. She participates in the annual Walk to End Alzheimer's in her hometown of Cedar Rapids, Iowa.

Lori began her railroad career in 1984 when she joined CSX Technology as a developer. She wrote software for a variety of applications, but it was the 28 years supporting the Locomotive Operations Department that she is most admired and remembered for by business partners and technology coworkers. When Lori decided to take the CSX buyout in 2015, she was one of a select few who was held over for six months to train her replacements since her subject matter expertise was unmatched. Lori participates in many Florida East Coast Railway events where her husband works. She is a mentor to new volunteers and their families about safety on and around trains. For nine years, she has been an elf on their annual Santa Train. Lori is a member of the Supervisory Committee at Coastline Federal Credit Union, which is responsible for ensuring that the credit union meets required financial reporting objectives and ensuring that practices and procedures are sufficient to safeguard members' assets.

Omaha Chapter - Julie Nelson



Julie joined Omaha NARBW in 2009. She has recruited new members and has served as chapter Treasurer, Finance Chairman, and Convention Registration Chairman. On the National level, she has served as Treasurer and Welfare, Credentials, Resolutions, and Rules Chairman. She has also assisted the National Board with reviewing the National Treasurer's reports and helping Board members understand the financial reports. Julie is the in-house expert on the chapter's Standing Rules; she helps members understand them and, if necessary, helps to amend them. She is currently the Registration Chairman for the 2024 Convention.

She was recently rated as Far Exceeds in several areas of her annual review by the credit union's Board of Directors, which means her performance is consistently above the standards expected of an individual with her training and job experience.

Philadelphia Chapter - Helena Funk



From the first meeting Helena attended in 2018, she fully committed to the NARBW and her member sisters, who were hosting the 2019 Convention. She designed and created the Convention contest entry, made various Convention decorations and marketplace pottery items, and eventually chaired the committee. The chapter won the first Founder's Day Gold Medal because of her creative talents. Since, she has planned and managed the chapter's Founder's Day events.

Mona became a member of the Roanoke Chapter on May 6, 2014. During her time with the chapter, she has served as secretary (currently in her 2nd term), Chairman of the Ways & Means Committee, and Chairman of Press & Publicity/Facebook.

Mona's railroad connection is through her father who was a longtime NS employee. Both of her grandfathers, her dad, and two of uncles worked for the railroad. After transferring from West Virginia to Indiana, Mona was 3 months shy of turning 16 when they were transferred to Roanoke in 1974.

After 32 years of service to the Commonwealth of Virginia, Mona retired on July 1, 2011.


